\$100 Deposit= (10'x20' spaces) An additional fee of 10% of sales will be charged at the end of the event. All vendors must submit a receipt of final sales to Easter Seals Central PA along with final payment by August 15, 2012. Includes admittance to event for four individuals to man booth.

**10% of sales fee will be waived, if vendor donates a product/service to our raffle/silent auction.
Product must have a value of \$100 or more.**

We are not allowing "flea market" type displays of second hand items at this event.

EVENT RULES AND REGULATIONS



1. The following are **STRICTLY PROHIBITED** from being sold, given away or offering information regarding: fireworks, knives, num-chucks, obscene materials, body piercing, tattoos, throwing stars, string spray, drug related items, alcoholic beverages (unless authorized by Easter Seals Central Pennsylvania), open flames (except for cooking), sale or donation of live animals, gambling, weapons of any kind including toy weapons and pets of any kind.
2. In the event you cancel your participation, no refund will be given. It will be a rain or shine event and no refunds will be given due to inclement weather. All non-returned application fees will be donated directly to Easter Seals Central PA.
3. Vendors may set-up beginning at 1 pm on Friday, July 27, 2012 **ONLY!** Vendors must be ready to open for business by 4:00 pm. All vehicles **MUST** be parked, unless they are able to fit in your purchased space by 3:30 PM. All displays must be removed from the location by 11:30 pm on Friday, July 27, 2012.
4. No removal of booth displays prior to 10:30 PM on Friday, July 27, 2012. Any questions regarding teardown, please direct to Christina Witmer at 717-591-7027 ext 5392.
5. Easter Seals Central PA and/or Naylor Wine Cellars will not be held responsible for any lost, stolen and/or damaged property or goods.
6. All vendors must stay within their booth space to sell products. At no time, are you allowed to solicit attendees outside of your designated space. If any complaints are received from attendees, you will be asked to leave and/or will not be allowed to come back to future events.
7. No spaces are to be subleased and/or given away. Encroachment on spaces not assigned to you is not permitted and is subject to an additional fee for that vendor space.
8. All food and beverage vendors are required to use utensils or wear gloves when handling food at the event. Do **NOT** dump grease or cooking ingredients onto the property.
9. Gambling (games of chance) are not permitted. Games of skill are allowed.
10. Food and Beverages are available for purchase at the event. We do ask that you not bring any outside food and beverages into the show (if you are not an approved food/beverage vendor). You will be asked to take these items back to your vehicle.
11. You will receive a letter of thanks for your donation from Easter Seals Central PA after the event. Should you require additional confirmation of payment, please enclose a self-addressed stamped envelope with your payment.
12. Vendors who do not obey the above rules and regulations will not be invited back.

Vendor Suggestions



1. If shade is needed (fyi...it does get hot and you are outside with no shade!), please bring pop up tent to fit into your space. Tent must fit into your purchased area. If the tent encroaches on another vendor's space or is in the way of general attendance traffic, you will be asked to take down your tent. NO EXCEPTIONS!
2. Electricity is available for those needing MINIMAL electrical needs (for example: desk lamp for lighting after dark). Please bring an extension chord and a power strip if you would like access to electricity (minimal outlets available) Electricity is NOT available for any food/beverage vendors.
3. Minimal lighting is available after sunset. It is recommended that you bring a flashlight, desk lamp or other lighting, if you are displaying materials.
4. Tables are not provided; please bring your own table. Tables must fit into your purchased space.
5. Cell phone service is minimal, but does work, if you are using a credit card system that uses cell phone service.
